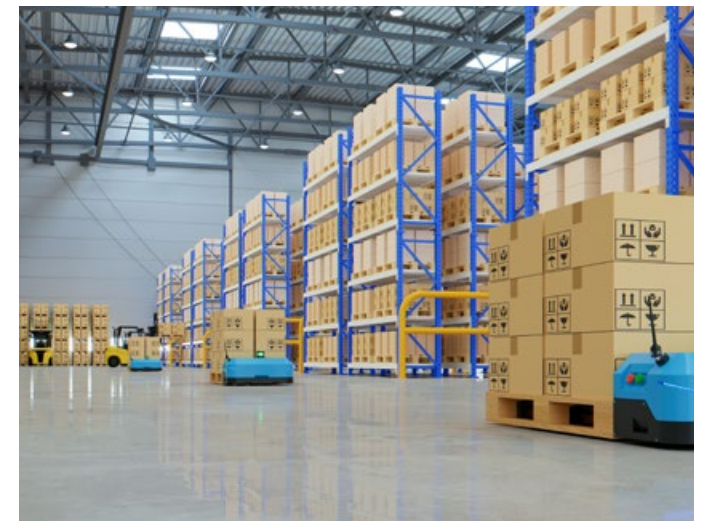
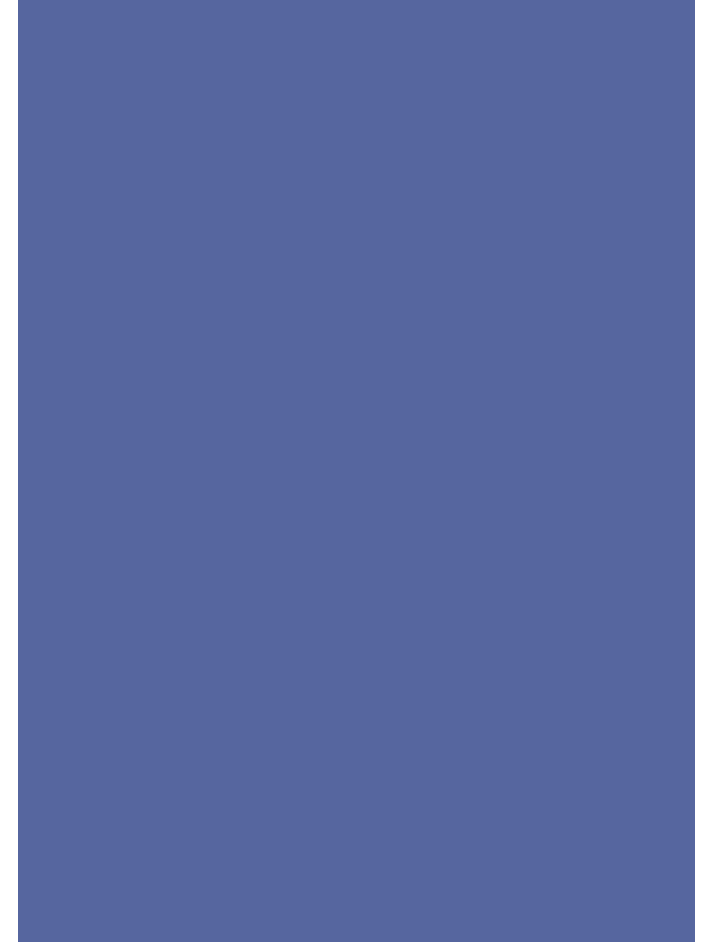

Examinations

D5 Managing contracts and relationships	60 MCQs. Select one correct answer from four options. There will be 15 MCQs testing each learning outcome.
